- 4. Translated copies of page No.17, 39-45 not filed.
- 5. Proper application for delay along with notarized affidavit not filed.
- 6. All annexures are not attested as true copies.
- 7. Submit the necessary certificate form duly singed.

Since the Petitioner has not cured the defects in spite of having been afforded three opportunities, vide proceedings dated 17.05.2018 the below mentioned information was sought from the Registry, as to whether:
