7	Brief statement of facts of the case and reasons for order	This is a Final Report filed by the Station House Officer of Amarapuram PS under Section 173 of Cr.P.C in Crime No.1 of 2016. On receipt of Notice, the De facto complainant appeared before the Court and requested time to file

		Protest Petition, but, despite granting more than sufficient time the De facto complainant did not choose to appear and file Protest Petition. Heard and perused the Final Report and its accompanied documents. It is seen from the Final Report that the Station House Officer of Amarapuram PS has registered a Case in Crime No.1 of 2016 for the offences under Sections 337, 304-A of IPC against one Bheemegowdegari Sreeramappa basing on the Report given by the De facto complainant by name Thippamma. It is alleged in the Report that on 12.01.2016 at 10:00 PM while the said Thippamma, as a Pillion Rider, was going to her village on the Motorcycle of Sreeramappa and when they reached near Kanakanapalli Village, one Sreeramulu came on their opposite direction on motorcycle in a rash and negligent manner and dashed against the motorcycle of Sreeramappa. As a result, the said Sreeramappa, Thippamma and said Sreeramulu fell down. Sreeramulu has received a severe bleeding injury on his head and died on the spot. Sreeramappa and Thippamma have received injuries. During investigation, the investigating officer has examined as many as nine witnesses and recorded their detailed statements under Section 161(3) of Cr.P.C. All the nine witnesses i.e., LW-1 to LW-9 with one voice stated before the Investigating Officer that the accident was occurred due to rash and negligent driving of Sreeramappa. The investigation also reveals that the said Sreeramappa was succumbed to injuries while undergoing treatment. There is no rival claim to the Final Report filed by the Investigating Officer. The Investigation done by the Investigating Officer is on proper lines. Hence, this Court is inclined to accept the Final Report. In the result, the Final Report is accepted and treated the Case as ABATED since the Accused is already died.
