BRIEF FACTS OF THE PETITION

The claim arises out of an accident caused by the Tractor bearing No.AP-05-DS-6159 and Trailer AP-05-TF-1383, owned by the 2nd respondent and insured with the 3rd respondent.

This petition is coming on for final settlement in the presence of petitioner and 3rd respondent and Sri. J. Venkateswara Rao, Advocate for Petitioner and Sri. Md.Abdul Raheem, Advocate for 3rd respondent are present before the Lok Adalat. Both parties to the petition and have agreed for amicable settlement with free will and volition. Hence, the following award is passed as per the settlement arrived by the parties.

AWARD UNDER SEC.21 OF THE LEGAL SERVICE AUTHORITY ACT 1987.

After negotiations and conciliation between the parties the claim of the petitioner is settled Rs. 2,00,000/- (Rupees Two Lakhs only) with interest and costs and an award is passed accordingly. If the 3rd respondent does not deposit the above amount within one month from today amount so awarded shall carry interest at 6% p.a., from the date of the award. The court fee, if paid shall be refunded.

DISBURSEMENT

The petitioner is permitted to withdraw an amount of Rs.2.00.000/- (Rupees Two Lakhs only)
