JUDGMENT:

By filing the present suit, the plaintiffs have claimed

themselves to have become owners in possession of the land measuring

93 kanals 0 marla on the basis of an agreement dated 21.7.2017 by virtue

of which the defendants voluntarily relinquished their tenancy rights and

from the date of agreement the plaintiffs are in actual physical possession

of the land in dispute and the defendants have no right, title or interest in

the suit property and the entries in the column of cultivation in the name

of defendants are incorrect, against law and liable to be rectified.

2- Upon the suit being filed, notice was given to the

defendants. Defendants appeared and stated regarding compromise in the

matter. Compromise Ex.C-1 has been also placed on the file. Statement

of the parties also recorded separately duly identified by their counsels.

3- The file was taken up in the National Lok Adalat.

Parties to the suit are not at issue. In view of the compromise Ex.C-1, an

award is hereby passed in favour of the plaintiff and he is declared to be

in possession of the suit land, as fully detailed and described in the head

note of the plaint by virtue of compromise Ex.C-1. The parties shall

remain bound by their statements. Ex.C-1 is made part and parcel of the

award. As per certificate of counsel for defendant no.6 minor and affidavit

of her mother Sumitra, the compromise is in the interest of minor Ankit.

Since minor cannot cultivate the land on his own and considering the fact

that he is not even a recorded owner, compromise in the opinion of the

court also is in interests of the minor. However, it is ordered that

proportionate amount of minor be kept deposited in his bank in form of a

saving or a fixed deposit and be made available to him upon attaining age of majority. The parties are, however, left to bear their own costs. Revenue record be rectified accordingly. File be consigned to the record room, after due compliance.
