2. Brief facts of this case are that on 04.09.2017 at 11.30 o'clock

in the night, complainant alongwith Ravinder and Harpreet was going on

motorcycle to Juneja Dhaba for having dinner and in the way, accused

Billa called Ravinder in the three-wheeler in which Babu and Pandit were

already sitting. Sanjay @ Billa was having a knife in his hand and he gave

knife blows on the chest, stomach, mouth, ear, shoulder of Ravinder and

Babu who was having gandasi attacked on Ravinder. Pandit who was

having Sariya also attacked on Ravinder and gave various blows on his

person and thereafter Billa caught hold him and gave knife blows on his

chest, stomach and arms and thereafter, Billa gave knife blows to Harpreet

on his stomach and thereafter when they raised hue and cry, accused

persons ran away from the spot by giving threat of life to them. With these

allegations, a prayer for taking necessary legal action against the accused

persons was made. Thereafter, on this complaint, the instant FIR was

lodged. Investigation into the case was carried out. Statement of witnesses

u/s 161 Cr.P.C were recorded. The accused persons were arrested during

investigation. After usual formalities of investigation, a final report u/s

173 Cr.P.C was forwarded to the court against the accused persons under

the above-said section.

3. Copies of challan has been supplied to accused persons free

of costs as envisaged under Section 207 Cr.P.C.

4. I have perused the challan, documents placed on the case file.

Since the offence punishable under Section 307 IPC is exclusively triable
