<u>ORDER</u>

This is an application for grant of succession certificate in favour of the applicants in respect of the debts and securities mentioned in the application stated to have been left by one Mst Hajira Begum W/o Abdul Gani Hajam D/o Gh Rasool Thokar R/o Naid Gund Trenz Shopian.

The application was presented on 1.02.2018. Applicants have produced two witnesses namely Mohd Amin Dar S/o Abdul Ahad Dar and Gh Ahmad Hajam S/o Mohd Sultan Hajam, besides statement of applicant No 2 as his own witness has been recorded. They have stated that they know the parties and also the deceased. They have stated that parties to the suit are the legal heirs of the deceased.

I have heard Ld. Counsel for the applicant and perused the material on record.

The statement of witnesses does prove that parties are legal heirs of deceased and respondent No.1 & 2 having relinquished their share in favour of petitioners. Therefore, this application is accepted and succession certificate in respect of debts and securities mentioned in the application i.e Rs 2,46,000/-lying with J&K Bank Branch unit H.R Shopian is granted in favour of applicants in equal shares along-with interest if any, subject to the furnishing indemnity bond by the applicants to the effect that in the event any other person making out a better claim to the said amount, they shall reimburse the same. The certificate be issued accordingly after requisite Court fee is paid. The application is accordingly disposed of and shall go to records after its due completion.
