6. **Point No.1**: In order to prove the point, the petitioner No. 1 has filed affidavit in lieu of examination in chief examination as PW1 and

retreated the petitoner awareness. She has got marked as Ex.P1 to 4. Ex.P1 is non availability certificate. Ex.P2 is notarised copy of SSLC marks card, Ex. P3 is notarised copy of passport and Ex.P4 is notarised copy of Adhaar Card.
