-: Committal Order U/s 209 Cr.P.C. :-

Accused present. The C.P.I., Nanjangud has filed charge sheet against the accused for the offences punishable under Section 342, 304 R/w., Section 34 of IPC.

2. Charge sheet copy supplied to the accused as required under Section 207 of Cr.P.C. Having perused the prosecution papers prima facie there are sufficient materials to proceed against the

accused persons for the offences as alleged under Section 342 and 304 R/w., Section 34 of IPC. The offences punishable under Section 304 of IPC is exclusively triable by the court of Sessions. Hence this case is required to be committed to the Sessions court. Before committing the case accused persons are called upon to furnish surety to ensure their presence before Sessions Court. Hence, I proceed to pass the following :

ORDER

Case is committed to the court of Hon'ble District & Sessions Court, Mysuru for trial.

Accused shall furnish personal bond for Rs.1,00,000/- each, with a surety for the likesum to ensure their presence before Sessions Court.

Surety by name Mahadeva s/o.Puttasiddegowda, R/o.Korehundi village, Kasaba Hobli, Nanjangud Taluk, already filed his surety affidavit on 20.01.2018, willing to stand as surety for the accused No.1 and 2 by producing solvency certificate, RTC., extract in respect of survey No.177 of Kallahalli village, as well as copy of Aadhar Card.

Surety by name Siddamma, W/o.Siddamallaiiah, @ Siddamalegowda, Aged 60 years, R/o.Korehundi village, Nanjangud Taluk, already filed his surety affidavit on 20.01.2018, willing to stand as surety for the accused No.3 by producing solvency certificate, RTC., extract in respect of survey No.78 of Deburu village, as well as copy of Aadhar Card.

Surety by name Puttaswamy s/o.Late Sannegowda, Aged 60 years, R/o.Korehundi village, Kasaba Hobli, Nanjangud Taluk, already filed his surety affidavit on 20.01.2018, willing to

stand as surety for the accused No.4 by producing solvency certificate RTC., extract in respect of survey No.191 of Deburu village, as well as copy of Aadhar Card.

The above said sureties present before the court and filed affidavits stating that, they are willing to continue their sureties for committal also.

Heard. Sureties are accepted.

Office is hereby directed to submit the entire case records and property of this case to the Hon'ble District & Sessions Court, Mysuru.

Issue Notice to Public Prosecutor regarding the committal of the case.

Office to take bonds.

Accordingly this case stands committed to the court of Hon'ble District & Sessions Court, Mysuru for trial.
