

The case is advanced upon an application filed by learned counsel for accused No.1.

The accused No.1 is present.

Sri. V.F.K. & Sri. JGM advocates have filed power to accused No.1, the bail application U/sec. 436 Cr.P.C., an application U/Sec.70(2) Cr.P.C. and the surety affidavit with documents.

Learned A.P.P. has been incharged to the court of Sirsi and he is not available to serve the copy of the bail application.

Heard learned counsel for the accused.

In the bail application, it is urged that the Siddapur police have filed the case U/secs. 279, 304-A of IPC and Secs.180, 181, 184, 187 & 196 of M.V. Act against the accused; the accused has not committed any offence; the said offences are bailable in nature; they are triable by this court; the presence of the accused No.1 is not required to the police as charge sheet has already been filed; the accused will not flee from the jurisdiction

of the court; he will attend before the court for all the hearing dates and he is ready to comply the conditions to be imposed by the court. Accordingly, learned counsel for accused No.1 has prayed to release him on bail.

The alleged offences are bailable in nature. The investigation is already completed and final report is also filed. Thus, the court is of opinion that the accused No.1 is entitled to enlarge on bail. Hence, I proceed to pass the following:

::ORDER::

The bail application filed by the accused No.1 U/sec. 436 Cr.P.C. is hereby allowed with the following conditions:

- 1) The accused No.1 shall execute bail bond for Rs. 5,000/- with a surety for like sum.
- 2) The accused No.1 shall appear before the court regularly without fail.
- 3) The accused No.1 shall not threaten the prosecution witnesses in any manner.

The surety by name Neelappa Lokappa Lamani, A/a. 45 years, occ: agriculturist, R/o. Shegighatti village of Kalghatagi taluk, Dharwad

district is present and undertakes to stand as surety to the accused No.1.

He has furnished surety affidavit, copies of his Aadhaar card, election ID card and ration card and the R.T.C. of the property bearing Sy.No.4/B2 measuring 2-15-0 situated at Shegighatti village in Kalghatagi taluk.

The court is satisfied about surety.

Office is to take bail bonds of the accused No.1 and surety.

The copy of charge sheet is furnished to accused No.1 as per section 207 Cr.P.C.

As the accused No.1 has been absent for last two hearing dates and the warrant has been issued against him for two times, it is necessary to allow the application filed U/Sec.70(2) Cr.P.C. on costs. Hence, it is hereby allowed on costs of Rs.100/-. The warrant issued against him is recalled. Issue intimation to police.

The accused No.1 shall pay the costs of Rs.100/- to T.L.S.C.
