- 1 That, the both the parties have filed compromise petition U/Or. XXXIII R 3 of CPC is hereby allowed.
- 2 That, the plaintiffs have given up their share for partition in respect of the plaint 'A' schedule property and defendants 1 and 3 to 8 also give up their share in respect of the plaint 'A' schedule property in favour of the 2nd defendant for the total consideration amount of Rs. 7,50,000/-

- 3 the plaintiff No.1 That, received consideration amount of Rs. 1,25,000/the plaintiff No.2 to 14 jointly received Rs. 1,25,000/- plaintiff No.15 to 25 received total amount of Rs. 1,25,000/- jointly, plaintiff No.26 to 31 received amount of Rs. 1,25,000/- the plaintiff No.32 to 43 jointly received Rs. 1,25,000/- and the defendants 1, 3 to 8 received total sum of Rs. 1,25,000/- from the 2^{nd} defendant. said consideration amount is being paid as cash. The plaintiffs and defendants No.1 and 3 to 8 acknowledge the receipt of payment. Therefore, the plaint A schedule property may be exclusively and absolutely allotted to the 2nd defendant Musthak Mohammed only and alone.
- 4 That, the 2nd defendant is put in exclusive possession of the plaint 'A' schedule property with the building and other improvements standing therein who shall enjoy the plaint 'A' Schedule property as the absolute owner thereof. The plaintiffs and defendants 1 and 3 to 8 or any persons

claiming through or under them have no any further claim by them or their respective their legal heirs in future in respect of the plaint property on against the 2^{nd} defendant.

3 That, compromise petition shall be part and parcel of the decree.
