JUDGMENT

(Delivered on 12th September, 2018)

1. This is petition filed by petitioners for decree of divorce by mutual consent under section 28 of the Special Marriage Act.
2. The marriage between the petitioner No.1 and 2 has been solemnized on 12.01.2016 before Registrar of Marriages, at Ahmednagar as per Hindu religion. They both have filed application under Section 28 of the Special Marriage Act for dissolution of their marriage by mutual consent.
3. On 28.02.2018, at the time of filing of the petition, petitioner Nos.1 and 2 were present before the Court. My learned predecessor made query with them to ascertain the fact that both the petitioners have voluntarily given consent to divorce. They have also produced their affidavits at Exh.6 and Exh.7 to pass consent decree of divorce and informing that they are firm on their decision of taking mutual divorce. Consequently after the span of more than six months, they pray for decree of divorce as

there is no possibility of their reunion. After ascertaining the said fact that consent was a voluntary consent, as per the affidavits in lieu of examination-in-chief as well as affidavits after gap of more than 6 months, they are firm on their decision and ruled out the possibility to lead their married life.

4. Today both the petitioners are present in the Court, I made query with them in camera. In reply to the query, petitioner Nos.1 and 2 replied to the Court that they are firm with the same view which they had while presenting the application under Section 28 of the Special Marriage Act.

5. In view of these facts both the petitioners are firm with their decision of taking divorce, by way of consent. Hence I pass the following order :

ORDER

1. The marriage between Sou. Komal Subhash Gunjal (petitioner No.1) and Shri. Subhash Bharat Gunjal (petitioner No.2) which had taken place on 12.01.2016 before Registrar

of Marriages, at Ahmednagar is hereby dissolved.

2. No order with respect to the alimony as the petitioner No.1 is not claiming any alimony after the consent divorce.
3. No order as to costs.
4. Decree be drawn up accordingly.
