ORDER

(Passed on this 18th day of August, 2018.)

- 1. This is an application for grant of heirship certificate under Section 2 and 3 of Bombay Regulation Act 1827.
- 2. Applicants' case is that deceased Liladhar S/o Ramkrushna Chachire died on 09-07-2017. He was residing at Dongargoan, Tah. Mohadi, Dist. Bhandara. He was serving as a peon in Pashudhan Vikas Adhikari, Panchayat Samiti, Lakhandur Tah. Lakhandur Dist. Bhandara. It is further contended that applicant No.1 is his wife and 2, 3 and 4 are the daughter and 5 is the son of deceased. It is contended that after the death of deceased Liladhar S/o Ramkrushna Chachire applicant No. 1 approached Pashudhan Vikas Adhikari, Lakhandur for sanction of amounts of Gratuity, P.F., Medical reimbursements and other monitory benefits standing in his name. It is contended that applicant no. 1 approached to Pashudhan Vikas Adhikari, Lakhandur but the concerned officer refused to give service as well as other benefit of her husband. She asked to bring legal heirship certificate. It is further contended that the applicants are the legal heirs of deceased and they are entitled for all the benefits leaving behind by the deceased Liladhar Chachire. It is further contended that the applicant no. 1 is the wife of deceased and entitled for amounts of Gratuity, P.F., Medical reimbursements and other monitory benefits. It is further contended that the legal heirship certificate is necessary for getting amounts of Gratuity, P.F., Medical reimbursements and other monitory benefits. Hence, this application.

- 3. In support of application, applicant No.1 Anita w/o Liladhar Chachire filed an affidavit vide Exh 14. On her evidence, original copy of letter issued by Pashudhan Vikas Adhikari, Panchayat Samiti Lakhandur is marked at Exh. 17, copy of death certificate of deceased Liladhar S/o Ramkrushna Chachire, is marked at Exh.18, copy of residental certificate issued by Grampanchayat, Dongargoan at Exh.19, verified copy of Adhar Card issued in her name at Exh. 20 accordingly, copy of newspaper of 'Punya Nagri' at Exh.21, copy of legal heirship certificate issued by Grampanchayat, Dongargoan at Exh.22. Proclamation is circulated in locality and also published in daily newspaper 'Punya Nagri' but no objection received.
- 4. Relying on the affidavit and documents filed on record by the applicant No.1, It can be stated that the applicants are the legal heirs of deceased Liladhar S/o Ramkrushna Chachire, and therefore heirship certificate under Section 2 & 3 of Bombay Regulation Act 1827 may be issued in their names. Hence, following order.

ORDER

- 1. Application is allowed.
- 2. Issue Heirship Certificate in prescribed form in the name of applicant No.1 Anita wd/o Liladhar Chachire, No. 2 Sima D/o. Liladhar Chachire, No. 3 Mina D/o. Liladhar Chachire, No. 4 Karishma D/o. Liladhar Chachire and No. 5 Amol S/o. Liladhar Chachire as they are the legal heirs of deceased Liladhar S/o. Ramkrushna Chachire.

Proceeding stands disposed off. 3.
