## Order Below Exh.01 (Dated 21/03/2018)

- 1] This is an application under section 372 of Indian Succession Act for getting succession certificate in the name of applicants.
- 2] According to applicants, father of applicant No.1 to 5, father-in-law of applicant No.6 and grandfather of applicant No.7 & 8 namely Hari Supda Umale died on 14-10-2013. So also, mother of applicant No.1 to 5, mother-in-law of applicant No.6 and grandmother of applicant No.7 & 8 namely Annapurna Hari Umale died on 30-09-2012. Amount of Rs.82,063/- is lying in the saving account of deceased Hari Supda Umale & amount of Rs.67,366/- is lying in the saving account of deceased Annapurna, maintained with State Bank of India, Branch Motala.

It is averred by applicants that, they are the only heirs of deceased Hari Umale and Annapurna Umale.,

3] Proclamation Exh.08 was issued on 25-01-2018. Public notice was also published in daily newspaper "Punya Nagri" on 31-01-2018. Copy of said public notice is at Ex.19. Till today, no objection is received to the claim of

the applicants. Applicants have filed death certificate of Dadarao Umale (who was husband of Kalpana) at Exh.12. Death certificate of Annapurnabai Umale is at Exh.13. Death certificate of Hari Supda Umale is at Exh.14. Heirship certificates issued by Sarpanch, Shirwa are at Exh.15 & 16. Heirship certificates issued by Police Patil, Shirwa are at Exh.17 & 18. Applicant No.6 filed her affidavit in the form of examination in chief at Exh.11. Evidence adduced by applicants remained unchallenged. It appears from the evidence on record that applicants are legal heirs of deceased Hari Umale and the only Annapurna Umale. Applicants only succeeded the amount in the both the accounts, they are entitled for the amount lying in the account of both the deceased. In my view, there is sufficient evidence to issue Succession Certificate in the name of applicants as prayed. In the result, following order is passed.

## **ORDER**

- 1] Application is allowed.
- 2] Issue Succession Certificate in the name of applicants
  - a) Digambar Hari Umale, Age 60 yrs.

- b) Sahebrao Hari Umale, Age 50 yrs,
- c) Aasha Bhimrao Kharate, Age 45 yrs,
- d) Chayawati Digambar Pawar, Age 42 yrs
- e) Savita Vitthal Surwade, Age 40 yrs,
- f) Kalpana Dadarao Umale, Age 32 yrs,
- g) Miss. Payal Dadarao Umale, Age 13 yrs,
- h) Mayur Dadarao Umale, Age Age 11 yrs,
