1. In response to the Judgment and order dated 09.02.2016 passed by this Court in Complaint (ULP)No.43 of 2014 granting monetary relief in favour of the applicant, present application for recovery certificate in the name of Collector, Sangli is filed. It is stated that despite of the order of the Court, the opponent did not

pay the amount. The opponent though duly served as per postal acknowledgement on record below Exh.O-2, he failed to appear and therefore, vide order dated 30.06.2018 matter is proceeded ex-parte against it.

2. The application is supported with affidavit of applicant stating that the opponent did not comply with the order and therefore, he did not receive the amount as ordered by this Court. Further the applicant has produced office copy of his application below list Exh.U-9 asking the opponent to pay his monetary dues as per Judgment and order dated 09.02.2016 passed by this Court in Complaint (ULP)No.43/2014, which is duly received by the opponent under their seal and signature on 20.02.2016. Considering the application filed below list Exh.U-9, I see no reason to discard the contention of the applicant about non-payment of amount by the opponent which is found supported with affidavit of applicant. Hence, application deserves to be allowed. Hence, the following order is passed.

: ORDER :

- 1) The application is allowed.
- 2) Issue recovery certificate for due amount i.e Rs.97,313/- (Rs.Ninety Seven thousand three hundred thirteen only) in the name of Collector, Sangli with request to recover the due amount from the opponent as a land revenue.
