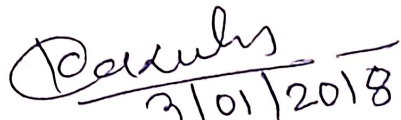

JUDGMENT

(Delivered on 03.01.2018)

The accused voluntarily pleads guilty, therefore, he is liable to be convicted. Heard the accused on the quantum of sentence. He submits that, he is poor and only bread earning member of his family. Therefore, he prayed for leniency. Considering submission of the accused, in my view, lenient view will have to taken. Hence, I pass the order.

ORDER

01] Accused Vitthal Mahadu Patil is convicted for the offence punishable under section 185 of the M. V. Act vide section 252 of the Code of Criminal Procedure and he is sentenced to pay fine of Rs. 2000/- (two thousand) and in default of payment of fine he shall suffer simple imprisonment for 15 days.
