charge you:-

as follows:-

Firstly, that you accused on 17-04-2017 at about 5.30
p.m. at Pangerewadi Tal.Rajapur, Dist. Ratnagiri you being a
public servant namely Assistant Inspector, Port Authority, at
Jaitapur Port after settlement demanded Rs.5,000/- (Rs. Five
thousand only) and accepted Rs.3,000/- (Rs. Three thousand only)
from complainant Shri.Suresh Ankush Bahire R/O Ansure
(Pangere), Tal.Rajapur Dist. Ratnagiri as he has not obtained
certificate of construction of house from Port Authority, for not

sending or submitting the report to higher authority for illegal house construction for yourself as a gratification other than your legal remuneration by abusing your position and thereby committed an offence punishable u/s 7 of the Prevention of Corruption Act 1988, and within my cognizance.

Secondly that you accused on aforesaid date, time and place have accepted Rs.3,000/- (Rs. Three thousand only) from complainant Shri.Suresh Ankush Bahire R/O Ansure (Pangere), Tal.Rajapur Dist. Ratnagiri as he has not obtained certificate of construction of house from Port Authority, for not sending or submitting the report to higher authority for illegal house construction for yourself as a gratification other than your legal remuneration by abusing your position and thereby committed an offence punishable u/s 13(1)(d)(i) r.w.13(2) of the Prevention of Corruption Act 1988, and within my cognizance.

And I hereby direct that you be tried by this Court on the said charge.
