## Order Below Exh. 1 in S. C. C. No. 01/2018

- 1. The complaint filed by Smt.Vaishali Patil, Tahasildar, Guhagar on behalf of State for the offences Punishable U/S. 171G, 177 and 181 of IPC. As the complainant is a public servant acting in the discharge of her official duties has made present complaint. The verification is not taken as contemplated U/S.200 of Cr.P.C.
- 2. Heard Learned A.P.P. perused the complaint, complainant submitted that by the letter dated 24/03/15 of State Election Commission. Maharashtra State, the election programme for Grampanchayat Shir was declared & Mr.P.K. Jakkar. Head of Kotluk Center was appointed as authotised person in said election. The accused has submitted Form on 6-4-15 and in the said form he furnishes false information and thereby accused with intent to affect the result of on election given false information and made false statement on oath to a public servant and thereby committed offences punishable U/S. 171G, 177 and 181 of IPC.
- 3. In support of complaint, complainant has produced documents along with list of document at exh.2. These documents includes Form of accused along with declaration dated 6/4/15, the letter dated 3-12-15 of Guhagar Police Station to file complaint in respect of cheating to Vasant Ambekar, the letter dated 24-2-16 of Guhagar Police Station relating to pendancy of case against offences punishable under 120B, 192,197,418 & 420 of IPC against accused. The

letter dated 12-4-16 of Collector Ratnagiri authorising the complainant to file complaint etc.

4. From the perusal of complaint and documents, the complainant established that accused has given false information and false statement. Accordingly prima facie there is sufficient evidence to issue process against accused the offences punishable U/S. 171G, 177 and 181 of IPC. Hence I pass following order.

## ORDER

- 1. Issue process against accused Shivram Hari
  Ambekar for the offences punishable under section
  171G, 177 and 181 of IPC.
- 2. Process be issued on P.F. returnable on 8/3/2018.
- 3. The matter be recorded as warrant triable case.
