## Cri. M.A.No. 01/2018 Meerabai ..vs.. G.P.Dhamni Khadi

#### ORDER BELOW EXHIBIT 01

This is an application filed by applicant Meerabai Nagorao Sable for issuing an order to get registered date of birth of her daughter namely Madhuri Nagorao Sable in the register maintained by the non-applicant.

- 2] Perused the application and documents. Heard learned Advocate for the applicant.
- The learned Advocate for the applicant submitted that, daughter of applicant namely Madhuri Nagorao Sable born on 15/07/1988 at village Dhamni [Khadi], Tq. Karanja, Dist. Washim but the said birth date is not registered with the non-applicant. Now the applicant require birth certificate of her daughter for educational and personal purpose. As there is delay in giving information to the concerned officer of more than one year, she moved the present application before this Court u/s 13(3) of Registration of Birth and Death Act, 1969.
- In support of her application, the applicant has filed non-availability certificate, copy of school leaving certificate of Madhuri Nagorao Sable, copy of Adhar Card of applicant and Residential Certificate of applicant issued by Gram Panchayat, Dhamni [Khadi] etc.
- In support of application, the applicant has also filed her affidavit on record. It appears from the said affidavit that, daughter of applicant, namely, Madhuri Nagorao Sable born on 15/07/1988 at village Dhamni Khadi, Tq. Karanja, Dist. Washim. There is nothing to disbelieve the said evidence of applicant on record. It is seen that, birth date of applicant's daughter is not registered with the concerned authority which is clear from the certificate issued by the concerned authority. As per section 13(3) of the Registration of Birth and Death Act, if any birth or death which has not been registered within one year of

its occurrence, the Magistrate has powers to order registration of birth or death on verification of correctness of birth and death. In present case, after due verification and on the basis of affidavit, the birth date of applicant's daughter namely, Madhuri Nagorao Sable as on 15/07/1988 at village Dhamni [Khadi], Tq. Karanja, Dist. Washim. There is nothing to disbelieve the said birth date of applicant's daughter is found to be correct. Hence, I proceed to pass following order.

## <u>ORDER</u>

- (i) The application is allowed.
- (ii) The non-applicant i.e. Secretary, Gram Panchayat, Dhamni [Khadi], Tq. Karanja, Dist. Washim, shall register 15/07/1988 as the birth date of applicant's daughter namely Madhuri Nagorao Sable.
- (iii) The non-applicant i.e. Secretary, Gram Panchayat, Dhamni [Khadi], Tq. Karanja, Dist. Washim is hereby directed to issue birth certificate on payment of the prescribed fees.
