Petition under Section 6 of Guardian and Wards Act read with Section 8 of the Hindu Minority and Guardianship Act for appointing the petitioner as a guardian of minor Ramanpreet Kaur (date of birth 4.2.2005), Amanpreet Kaur(date of birth 21.7.2009) daughters of deceased Ranjit Singh and Gurkarandeep Singh (date of birth 19.2.2011) son of deceased Ranjit Singh for permission to sell the land measuring 10 Kanal 3 Marla out of land measuring 61 Kanal 11 Marla consisting of Khasra No.8/23 (7-11), 8/24(8-0), 8/25/1 (5-8), 16/2 (6-2), 16/3/1 (3-18), 16/3/2 (2-15), 16/4/1 (1-15), 16/4/3 (1-10), 16/7 (1-7), 16/26 (0-8), 63/4(0-2), 63/5(0-2), 79 (1-2), 17/5/2 (1-6), Khewat Khatuni No.80/149-150, Khasra No.16/1 (9-2), Khewat Khatuni No.81/151, Khasra No.8/21/2 (3-12), 8/22 (7-11), Khewat Khatoni No.82/152 as per jamabandi for the year 2014-2015 situated at village Padde, Tehsil Baba Bakala Sahib, District Amritsar for the welfare and benefit of the minors.

ORDER:

1. Brief facts of the present petition are that the present petition has been filed by the petitioner against the respondent on the averments that petitioner was married with Ranjit Singh and out of their wedlock two female child namely Ramanpreet Kaur, Amanpreet kaur and one male child namely Gurkarandeep Singh were born and at present they are residing with petitioner. Ranjit Singh husband of petitioner had died on 6.6.2015 and after his death, mutation has been sanctioned in favour of petitioner and minors, vide mutation No.847 dated 9.12.2015. The minors are co-sharers to the extent of land measuring 10K-3M out of the land measuring 61K-11 marlas. The petitioner intend to sell the land of the minors for the better future of the minors and to give them higher education. It is averred that the land measuring 10K-3M, which is in the name of minor exists in different three Khewats and joint with other coshares and has not been partitioned so far. The minors are not in possession of the same, but the same is under possession of other cosharers and as such it is difficult for them to get cultivate the land of their share. The land of the minors are not yielding any income because the land is in possession of other co-sharers. The petitioner will not misuse the sale proceeds so received by her by selling the land of minors. The petitioner undertakes to deposit the sale amount in the name of minors

after selling the land of minors in a Nationalized bank in the shape of

FDR till their majority. The petitioner is a real mother and natural

guardian of the minors and as such she be appointed as guardian of

minors. Hence this petition.

2. Notice of this petition was served to respondent General

Public through publication in newspaper. However, none has appeared on

behalf of respondent General Public to contest the claim of petitioner and

as such respondent was proceeded against exparte, vide order dated

19.3.2018.

3. In order to prove her case, petitioner Balveer Kaur appeared

in the witness box as AW1 and tendered her duly sworn affidavit

Ex.AW1/A, wherein she reiterated the facts mentioned in the petition. She

also placed on file attested copy of birth certificate of Ramanpreet Kaur

as Ex.P1, attested copy of birth certificate of Amanpreet Kaur as Ex.P2,

attested copy of birth certificate of Gurkarrandeep Singh as Ex.P3,

attested copy of death certificate of Ranjit Singh as Ex.P4. Her version is

corroborated by PW2 Udham Singh Numberdar of village Padde, Tehsil

Baba Bakala Sahib, District Amritsar. Thereafter learned counsel for the

petitioner closed the exparte evidence.

4. I have heard the ld.counsel for the petitioner and have gone

through the documents placed on file very carefully. While appearing in

the witness box, as AW1 Balveer Kaur petitioner, reiterated her version as

taken in the petition. Perusal of the revenue records including fard hakikat

shows the ownership of minor qua property mentioned in petition. Further relationship of petitioner with minors have also proved by PW2 Udham Singh numberdar of village Padde, Tehsil Baba Bakala Sahib, District Amritsar. Notice was also issued to General Public but none appeared to raise objections and as such it cannot be said that conduct of Balveer Kaur is suspicious or against the minors. Petitioner Balveer Kaur is natural guardian and mother of minors and as such, she can seek better prospectives for her minor children and their properties. As such, present petition is allowed and petitioner Balveer Kaur, is appointed as guardian of minors Ramanpreet Kaur, Amanpreet Kaur and Gurkarandeep Singh with the permission to sell the land measuring 10 Kanal 3 Marla out of land measuring 61 Kanal 11 Marla consisting of Khasra No.8/23 (7-11), 8/24(8-0), 8/25/1 (5-8), 16/2 (6-2), 16/3/1 (3-18), 16/3/2 (2-15), 16/4/1 (1-15), 16/4/3 (1-10), 16/7 (1-7), 16/26 (0-8), 63/4(0-2), 63/5 (0-2), 79 (1-2), 17/5/2 (1-6), Khewat Khatuni No.80/149-150, Khasra No.16/1 (9-2), Khewat Khatuni No.81/151, Khasra No.8/21/2 (3-12), 8/22 (7-11), Khewat Khatoni No.82/152 as per jamabandi for the year 2014-2015 situated at village Padde, Tehsil Baba Bakala Sahib, District Amritsar for the welfare and benefit of all the minors as prayed for. The petitioner is further directed to deposit the sale proceeds of the land in question, in the name of minors Ramanpreet Kaur, Amanpreet Kaur and Gurkarandeep Singh, till the period they attain majority, in the shape of FDRs in some Nationalized Bank, under intimation to this Court. The petitioner is

however, at liberty to withdraw the amount of interest on the fixed deposits, so made for maintenance, education, welfare and upkeep of the minors. File be consigned to record room.
