J U D G M E N T

1. The above named accused was apprehended and was sent to face trial for commission of an offence punishable U/s 147 of the Indian Railway Act.

2. The brief facts of the case of the prosecution are that on 26.11.2017, at _____ hours, in the circulating area of Railway Station, Bathinda, Investigating Officer found the accused crossing his vehicle below the railway phatak without any valid permit or license. He then informed him about the offence committed by him under Section 147 of the Indian Railway Act and arrested him. On asking, he disclosed his name as aforesaid accused. His personal search was conducted. RC was recovered from him. The offence being bailable, the accused was released on bail. After completion of necessary formalities, the Calendera was

presented in the court.

3. Complete copies of documents were supplied to the accused free of costs.

4. A prima -facie case for offence U/s 147 of the Indian Railway Act was made out against the accused. Notice of the accusation was served upon him, the contents of which were read over and explained to him, to which he pleaded guilty and did not claim trial. His separate confessional statement was also recorded in this regard.

5. This court is satisfied that accused has made confession voluntarily, without any pressure or coercion. Therefore, relying upon the same, the accused is held guilty for commission of offence U/s 147 of the Indian Railway Act and convict him thereunder. Let, he be heard on the question of sentence.
