## **BAIL APPLICATION**

Present: Sh. Nitin Berry Ld. APP for State Sh. Harvinder Pal, Adv. Counsel for applicant/accused Jagga and Guggu @ Jasvir

- 1. Notice of the application was issued to the State, however no written reply has been filed by the Ld. APP for State. However, Ld. APP for State orally contested the application.
- 2. Heard. Ld. Counsel for applicants/accused submitted that the accused have been falsely implicated in this case and accused are not included in FIR and the accused have no knowledge regarding the said offence. Further, it was submitted that the accused are in custody since 16.12.2017. Conclusion of trial will take time and no useful purpose would be served by detaining the accused behind bars. With this submission Ld. Counsel prayed that applicant/accused be released on bail.
- 3. Par contra Ld.APP for State argued that case against the accused is registered for commission of a grave offence and if they are released on bail, They are likely abscond and to interfere in investigation. With this Ld. APP for State prayed that the application be dismissed.
- 4. I have heard the rival contention. Record reveals that accused Jagga and Guggu @ Jasvir are in custody since 16.12.2017. The F.I.R has been registered U/S 379,411 IPC. The fact that the accused are in judicial custody goes to shows that he is not required by the police for

further investigation. Presentation of challan, conclusion of trial will take

time and accused cannot be detained for an indefinite time. No useful

purpose would be served by detaining the accused behind bars. As such,

applicant/accused Jagga and Guggu @ Jasvir are admitted to bail subject

to furnishing bail bonds in the sum of Rs. 50,000/- each with one surety

each in the like amount, subject to following conditions:-

1. The accused shall appear in the court on each and

every date of hearing during trial without fail;

2. The accused shall not absent himself during trial of

the present case;

3. The accused shall not leave India that prior permission of

the court.

5. Requisite bail bonds and surety bonds not furnished. Papers be

tagged with main file/remand papers.
