It is stated that compliance to the extent of passing the order has been made but due payment as a consequence of it has not been given to the five petitioners out of many though others have received the due amount.

Learned Additional Advocate General Shri Shyam Arya submits that directions have already been issued to make payment and actual payment has also been made.
