It is stated that the first page in Ex.P1 is score off, the answer is Yes. It is suggested that for scoring off, nobody has made side initial, the answer is Yes. It is suggested that in page no. 4 there is a hand written adding, in page 5 there is a scoring off and hand written, in page no.7 there is hand written adding, in page no.8,9,10,11,18 there is scoring and had written, the answer is Yes. It is suggested that in page no. 19 there is a striking off paragraph , the answer is Yes. It is suggested that in page no. 21 and 22, 23, there are insertions, the answer is Yes. The person who made such Additions, Insertions, Striking etc., had not initialed then and there, the answer is Yes. It is suggested that Ex.P1 is a photo copy, the answer it is certified by me. Whether I have seen the original the answer is after seeing the original I certified. It is suggested that the original is not seen by me, at the time of making and Endorsement of certification, the answer is I deny the same. Whether during a Police enquiry I have mentioned about the above aspects, the answer is only I handed over Ex.P1 at the time of investigation.
