Accused Smt. Usha Rani Debnath appears today and by fling a petition prays for fresh bail.

It appears from record that on 20.02.2015 this court allowed the accused person to remain on bail on her execution of a P.R. Bond of Rs.20.000/-.

Accused Smt. Usha Rani Debnath complied the directions issued by this Court. Hence, the petition filed by accused Smt. Usha Rani Debanth seeking for prays bail is hereby allowed.

Let the accused persons be relased on bail on her furnishing a bond of Rs.20,000/-(Rupees twenty thousand) only with one surety of like amount I.d to to 13.03.2015.

Another petition is filed by the accused Smt. Usha Rani Debnath stating that earlier she had executed a vokalatnama in favour of Mr. S. R. Bardhan, Ld. Advocate, for conducting the case for and on behalf of accused person. But at present the accused person has no independent source of income for which the accused person is unable to pay the fees claim by her engaged Ld. Lawyer for conducting the trial and as such the accused person prays for appointment of her engaged Ld. Lawyer Sri S. R. Bardhan as amicus curia, at the cost of supposed to be borne by the Govt. of Tripura.

Heard the Ld. Addl. P.P on the said petition and considered.

As accused Smt. Usha Rani Debnath herself suggest the name of Sri S.R. Bardhan as amicus curie, I hereby allowed her petition for the proper ends of justice.

Mr. S. R. Bardhan, Ld. Advocate, also gives his consent to conduct the trial as amicus curie. So, Mr. S. R. Bardhan, Ld. Advocate of Sonamura Bar Association is hereby appointed as amicus curie to conduct the trial on behalf of the charge sheeted accused Smt. Usha Rani Debnath and he will be entitled get to his fees as per approved Govt. rate.

Furnish a copy of this order to Mr. S.R. Bardhan, Ld. Advocate free of cost at once.

Heard Ld. Lawyers of both sides at length on the question of framing of charge.

While the Ld. Addl. P.P. Mr. S. Chakraborty and Ld. Amicus curie, Mr. S.R. Bardhan admitted that there are materials in record regarding of framing of charge under Section 326(A) of IPC. Accordingly, one formal charge is framed against accused Smt. Usha Rani Debnath with reference to the offence punishable under Section 326(A) of IPC but on being asked by this Court accused Smt. Usha Rani Debnath pleaded not guilty to the said charge and claimed to the tried.
