
This case is coming on today before me for committal in the presence of A.P.P. for the State and of Sri A. Nagaraju, Advocate for accused A1 to A6, and having been heard and having stood over for consideration to this day, the Court made the following:-

ORDER

- 1. The Inspector of Police, PS Siricilla filed charge sheet against the accused A1 to A6 for the offence punishable U/secs. 302, 201, 120-B r/w 34 and 109 IPC in Cr.No.316/2017.
- 2. The brief facts of the case are that the defacto complainant Shaik Sadik Pasha lodged complaint on 08-08-2017 stating that he is eking his livelihood by driving an auto and his father Shaik Nazeer Ahmad is also doing



the driving of the auto for eking his livelihood and on 07-08-2017 at about 16-00 hrs., while his father was at Vidyangar, Siricilla he received a phone call in which the caller asked him of hiring his auto to go to Gopalraopalli village and accordingly the father of the complainant left with the auto but he did not return to home till night and the complainant contacted his father over mobile phone but the same is found switched off and immediately he along with brothers of his father namely Shaik Jaheer and Shaik Jakeer went for search for his father but in vain and on 08-08-2017 the auto of his father bearing registration No.AP15Y 3541 was found parked nearby the tank area of Gopalraopalli village and some liquor bottles were also found over there and by giving the identification particulars of his father, the complaint was given by complainant for taking necessary action. During the course of investigation, it is established that accused A1 and A4 along with A5 hired the accused A2, A3 and A6 for committing the murder of the father of the complainant namely Shaik Nazeer Ahmad by keeping in mind the family disputes and in furtherance of their agreement the Accused A2, A3 and A6 took the Shaik Nazeer Ahmad to isolated hillock i.e., Bodagutta of Chinthaltana village of Thangallapalli mandal from Bodagutta village of Siricilla on the pretext of hiring his auto and then offered him liquor and killed him by strangulation, hitting of his head and chest with a stone resulting the father of the complainant died on the spot and after confirmation of the death the accused No.2, 3 and 6 left the dead body and got down from hillock and thereafter they also committed the acts of screening the evidence so as to divert the attention by way of throwing the liquor bottles and other articles of the father of the complainant into the bushes and parking of the auto of the father of the complainant with a



distance of half kilometer of at Pochammalakunta area and then they informed about committing murder of the father of the complainant to accused No.1, 4 and 5 and thus the chargesheet is filed against the accused A1 to A6 as they committed the offences punishable U/Secs.302, 201, 120-B r./w Sec.34 and 109 IPC.

- 3. This case was taken on file for the offence punishable U/Secs.302, 201, 120-B r./w Sec.34 and 109 IPC against the accused A1 to A6.
- 4. On appearance of accused A1 to A6, the copies of documents have been furnished to them as required under section 208 Cr.P.C.
- 5. Heard and perused the record. The offence alleged against the accused A1 to A6 U/Sec.302 IPC is exclusively triable by the Hon'ble Court of Sessions, Karimnagar. Accordingly, this case is committed to the Hon'ble Court of Sessions, Karimnagar U/Sec.209 (a) Cr.P.C. The accused are on bail, and they are permitted to continue on bail till the conclusion of Session's trial on the same terms and conditions imposed on them earlier by the Hon'ble Court of Sessions, Karimnagar. Bind over the accused to appear before the Court of Sessions on receipt of summons U/Sec.209 (b) Cr.P.C. The office is directed to submit the entire case records to the Hon'ble Court of Sessions, Karimnagar U/Sec.209 (c) Cr.P.C. Notify the committal of case to the Public Prosecutor, Karimnagar U/Sec.209(d) of Cr.P.C.
