THIS case coming before me for final hearing in the presence of learned APPO on behalf of the state and of Sri A Janaki Ramulu and A.Yadilal Advocates for the accused and having been stood over for consideration till this day, the court delivered the following:-

COMMITTAL ORDER.

- 1) The Circle Inspector of Police, Amangal laid charge sheet against A.1 to A.5 in Crime No.230/2017 for the offence U/s.498(A),307,497,109 R/w.34 IPC.
- The case of the prosecution is that on dated. 6.7.2017 at 0830 hours the complainant by name Vaspula Gopi S/o.Peddaiah R/o.Premnagar colony Amangal village came to PS and lodged complaint stating that at about 4 years back his sister's Balu's marriage (ie.,LW.7) was performed with A.1. Out of wedlock they blessed with one daughter. After their marriage, A.1 at the instigation of A.2 to A.5 started illtreating and harassing her both mentally and physically having developed illegal intimacy with A.5. On the intervening night of 6.7.2017 A.1 to A.5 decided to kill his sister and assaulted her with sickle on her throat, head and cheek and caused bleeding injuries and thereby she was shifted to Govt.Hospital, Amangal and from there to OGH.Hyderabad as such A.1 to A.5 are liable to be punished for the offence U/s. 498(A),307,497,109 R/w. 34 IPC.
- 3) This case was taken cognizance against the accused for the offence U/s. U/s. 498(A),307,497,109 R/w. 34 IPC.

- 4) On securing the presence of accused, copies of all relavant documents were furnished to them as contemplated U/s.208 Crl.PC. Having gone through the record, since the offence U/s.307 IPC is excusively triable by court of Sessions, this case is committed to Hon'ble court of Sessions. Since the accused 1 to 5 are on bail, they were directed to appear before the Hon'ble court of Sessions on dated. 23.4.2018.
- 5) The entire case record and material objects if any shall be submitted to the court of Sessions Mahabubnagar forthwith.
- The Public Prosecutor Mahabubnagar shall be notified about the commitment of the case when questioned about the means, they submitted that they got sufficient means to engage counsel to defend their case during the course of trial. The accused are hereby directed to appear before the Hon'ble court of Sessions Judge, Mahabubnagar on dated.23.4.2018.
