No. 1 Dt. 05.01.13 A plaint is filed by the plaintiff Basanti Rani Mondal against the defendant Madhab Bagdi and six pro-defendants supported by verification and affidavit praying for permanent injunction against the defendants and other reliefs. The plaintiff also files the vokalatnama of his engaged Ld. Advocate.

Let the same be registered as Title Suit. Court fee payable is Rs. 10/- and the plaintiff filed court fee of Rs. 10/- only which is provisionally accepted.

The Ld. Advocate for the plaintiff submits that the defendant no. 1 is totally a stranger to the suit schedule property and is threatening the plaintiff and other co-sharers of the suit property to disposses them from the suit property and also is trying to grab the suit property by way of digging and making pucca structure. Therefore, the plaintiff has filed the present injunction petition and prays for passing an order of ad-interim injunction restraining the defendant no. 1 not to disturb the plaintiff's peaceful possession of the suit property and in any way not to disturb their joint possession in the suit properties. The Ld. Advocate further submits that the xerox copy of information slip is filed by the plaintiff from which it will be seen that the names of all the pro-defendants and the plaintiff are recorded in respect of dag no. 669 in the status of 'bari'.

Considering the submission of Ld. Advocate for the plaintiff and perusing the case record including the document filed by the plaintiff, this court is of the view to allow the prayer of the plaintiff for ad-interim injunction against the defendant no. 1 for the reason that the plaintiff has made out his prima facie case to go into trial and the balance of convenience and inconvenience also till in favour of the plaintiff. At this stage if the suit property is not protected then the plaintiff may suffer irreparable loss of injury.

Hence it is,

ORDERED

That the prayer of the plaintiff for ad-interim injunction is

The defendant no. 1 is hereby restrained from disturbing the plaintiff's peaceful possession of the suit property and from disturbing from joint possession in any way in the suit properties till 04.02.13.

Issue notice upon the defendant no. 1 to show cause within 15 days of the receipt of the same as to why the prayer of the plaintiff for temporary injunction against him shall not be granted.

Plaintiff is directed to comply the provision of order 39 rule 3(a) and (b) of C.P.C.

Urgent requisites for issuing notice to be filed within 7 days from the date of this order.
