THE REPRESENTATION OF THE PEOPLE (AMENDMENT) ACT, 1966

ACT No. 47 of 1966

[13th December, 1966.]

An Act further to amend the Representation of the People Act, 1950, and the Representation of the People Act, 1951.

BE it enacted by Parliament in the Seventeenth Year of the Republic of India as follow:—

CHAPTER I

PRELIMINARY

- **1. Short title and commencement.**—(1) This Act may be called the Representation of the People (Amendment) Act, 1966.
- (2) It shall come into force on such date¹ as the Central Government may, by notification in the Official Gazette, appoint, and different dates may be appointed for different provisions of this Act.
