Overall Risk Score:

Moderate — The main risks derive from the absence of specific dispute resolution procedures and lack of detailed indemnity wording, which could complicate enforcement or conflict resolution.

Final Recommendations:

- Consult with a legal advisor to draft and incorporate a robust dispute resolution mechanism.
- Amend the indemnity clause to include specific steps and timeframes to enhance legal clarity and protection.
- Ensure both parties understand and agree to any additional clauses prior to finalizing the sale.
