You are hereby informed that the investigation of the above noted case is being conducted by the undersigned. On 13.03.19 an information regarding accident at police picket Haryana Maitry Bhawan was received at PS Rani Bagh vide DD NO. 11 A. After getting this information I along with staff rushed to the spot and found that injured had been shifted to Bhagwan Mahaveer Hospital. During inspection one car **Hundai Xcent bearing No. HR 55AD 8128** was found accidental condition at the place of occurrence. On enquiry it came into notice that driver of above car had committed an accident by hitting his car to the barricade and police officers, who were on duty. Due to that collision HC Vijay Kumar No. 1224/OD, Ct Rajbeer No. 1602/OD and one home guard namely Devender were got received injury. Driver namely Satnam Singh S/O Chatar Singh R/O H.NO. A-362, Ranjeet Nagar Delhi age 27 year was apprehended on the spot. Thereafter MLCs were collected from Bhagwan Mahaveer Hospital. On the statement of ASI Ramphal above mentioned case was registered and investigation taken up. During the course of investigation Car **Hundai Xcent bearing No. HR 55AD 8128** was taken into police possession through seizure memo.
