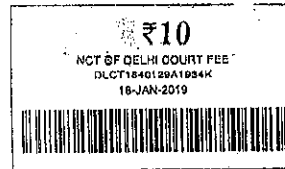
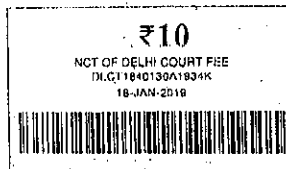

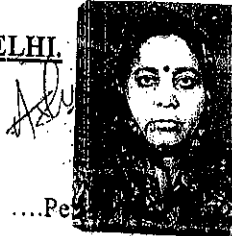

That on 07.08.2018 at about 02:00 a.m. to 02:30 a.m. Sh.Narender Kumar Bandhu (Since Deceased) along with his friend Raj Kumar was going to Haridwar from his house i.e.D-338-A, Gali No.19, West Vinod Nagar, Shakarpur, East Delhi, for taking Kavar (Ganga Jal) by motor cycle No.DL-5SBP-0547 (Splendor Pulse), which was being driven by Raj Kumar at a normal speed and on the correct side of the road and Narender Kumar Bandhu was a pillion rider. When the motor cycle reached Under Flyover Duhai, Near Chowki Vardhmanpuram PS:Murad Nagar, Distt. Ghaziabad, in the meanwhile a Car bearing registration No.HR-55AA-6577 (Swift Desire), which was being driven by its driver/respondent no.1, at a very high speed, rashly, negligently, without taking necessary precautions, without proper lookouts, violating the traffic rules and without blowing any horn came from wrong side and hit against the motor cycle with a great force. As a result of this they fell down on the road along with his motor cycle and Sh.Narender Kumar Bandhu and Raj Kumar sustained grievous injuries. That on the most unfortunate day of 07.08.2018 at about 02:00 a.m. to 02:30 a.m. Sh.Narender Kumar Bandhu (Since Deceased) along with his friend

Raj Kumar was going to Haridwar from his house i.e.D-338-A, Gali No.19, West Vinod Nagar, Shakarpur, East Delhi, for taking Kavar (Ganga Jal) by motor cycle No.DL-5SBP-0547 (Splendor Pulse), which was being driven by Raj Kumar at a normal speed and on the correct side of the road and Narender Kumar Bandhu was a pillion rider. When the motor cycle reached Under Flyover Duhai, Near Chowki Vardhmanpuram PS:Murad Nagar, Distt. THE PRINCIPLE OF RES-IPSA-LOQUITUR IS ATTRACTED IN THIS CASE.

This accident was caused due to rash and negligent driving of the respondent no.1. Had the respondent no.1 been careful and cautious enough this accident could have been very easily averted and the deceased would not have died an unnatural and untimely death in the accident.

That at the time of accident, the deceased was 23 years old and was possessing sound mind, good health and robust physique and was not suffering from any kind of ailment or addicted to any vice. He was working as a Supplier of Sweet Makers, Caterers & Waiters with Bandhu Cook & Caterers, D-338-A, Gali No.19, West Vinod Nagar, Shakarpur, East Delhi-110092 and was earning Rs.25,000/-p.m. to Rs.30,000/- p.m. He was leading a peaceful and comfortable life with the petitioners. Had he not died in the said accident, his income would have more than double and he would have lived a long life. The Petitioners suffered a great mental pain, shock and trauma. He was quite energetic, fore sighting and far sighting person.

The deceased has left behind his mother Smt.Raj Kumari, Aged 58 years and his father Sh.Chandrapal Singh, Aged 53 years who are the only legal heirs of the deceased. The deceased was unmarried promising young person. The petitioners were solely dependent upon the income of the deceased. Had he not died in the said accident he would have lived a long life with the petitioners. The entire life of the petitioners has become dark and gloomy. There is sadness in the family of the petitioners. The losses suffered by the petitioners are quite irreparable and no amount can compensate the losses suffered by the petitioners.

That respondent no.1 and 2 being the driver and owner of the offending vehicle are jointly and severally liable to pay compensation to the petitioners. The respondent No.1 was driving the said offending vehicle at the time of accident under the management and control of respondent No.2. The respondent No.2 being the owner is liable to pay compensation to the petitioners.

The petition is being filed before this Hon'ble Court as the petitioners are residing within the jurisdiction of PS:Shakarpur, East Delhi, which comes within the jurisdiction of East District and this Hon'ble Court has jurisdiction to try and decide the present petition as per Under Section 166 (2) M.V. Act.

The petitioners, therefore, claim a sum of Rs.35,00,000/- (Rupees Thirty Five Lacs Only) as compensation on account of sudden death of the deceased in the accident, towards mental pain and agony, loss of love and affection, loss of company, loss of income, loss of future income, loss of consortium, loss of estate, loss on funeral expenses and other general and specific damages as admissible under the various provisions of the Motor Vehicles Act be also granted to the petitioners along with interest @12% per annum from the date of filing the claim petition till its realization.

31. PRAYER

It is, therefore, prayed that this Hon'ble Court may be pleased to pass the claim compensation award for the sum of Rs.35,00,000/- (Rupees Thirty Five Lacs only) along with interest @12% p.a. from the date of accident till its realization in favour of the petitioners and against the respondents in the interest of justice.

An interim award Rs.50,000/- along with interest @ 12% u/s 140 of the Motor Vehicle Act, 1988, as amended upto date may also be passed in favour of the petitioners.

Any other relief/reliefs as the this Hon'ble Court may deem fit and proper in this circumstances of the this case in the interest of justice.

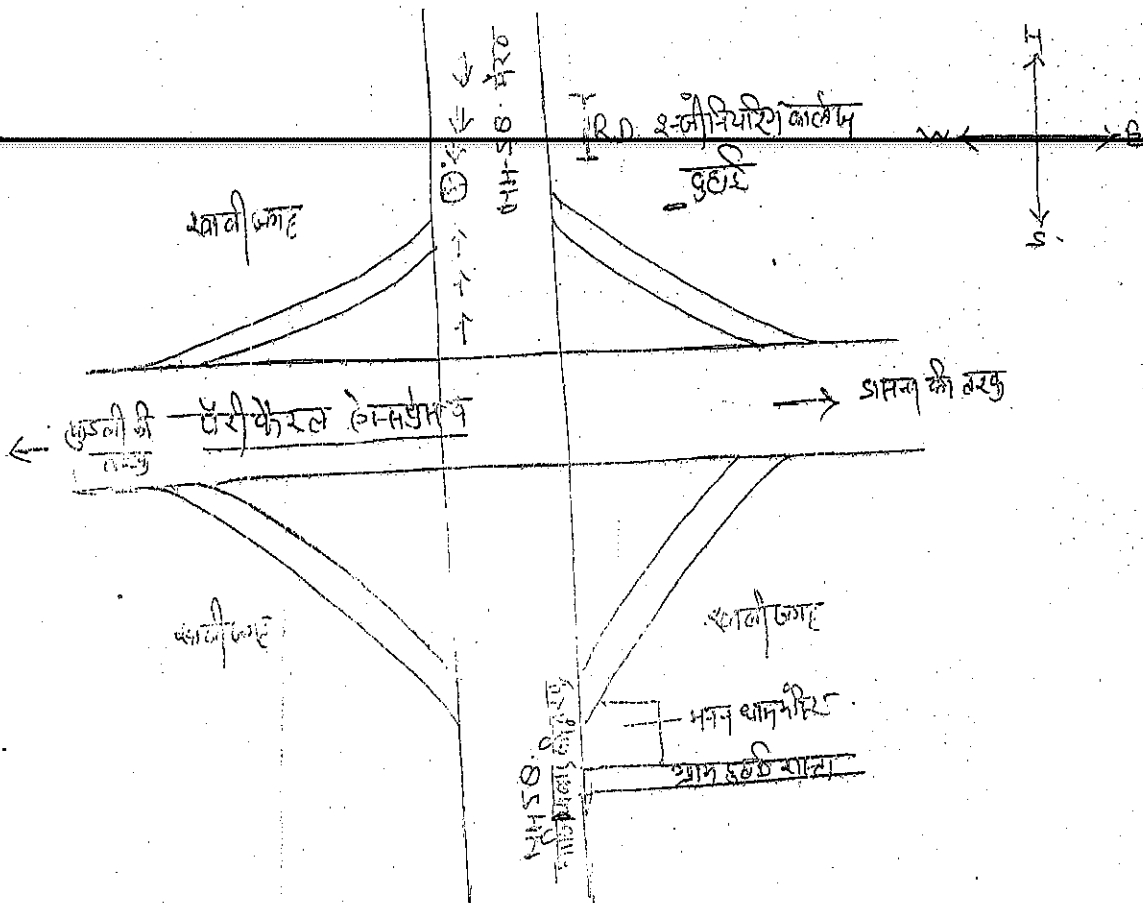

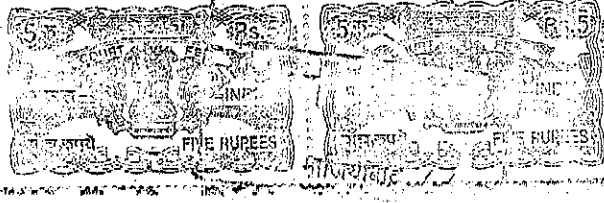

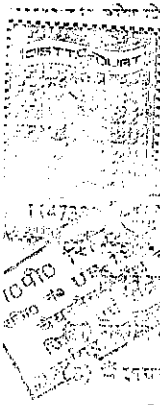
